### Grassilope

Tiny Beast, Unaligned

Armor Class: 12 Hit Points: 1 (1d4-1) Speed: 40 ft., burrow 10 ft.

#### Actions

**Mimicry:** The grassilope can mimic simple sounds it has heard, such as a person whispering, a baby crying, or an animal chittering. A creature that hears the sounds can tell they are imitations with a successful DC 10 Wisdom (In sight) check.

**Standing Leap:** The grassilope's long jump is up to 10 feet and its high jump is up to 5 feet, with or without a running start.

Claw: Melee Weapon Attack: +4 to hit, reach 5 ft., one target. Hit: 1 slashing damage

Appearance: With most of the moon being harsh, these creatures seem to have gone out of their way to be cute. They resemble a large, fat, and fluffy grasshopper drawn by a five year old. They have soft fur, soulful eyes, and huge furry antenna positioned like rabbit ears. They are well known for their cuddly nature, as well as their despicable cuteness. Their eyes are brilliant golden brown and expressive. Their four legs end in two toed clawed feet which are for digging as opposed to fighting.

**Size:** As newly born maggots they're little more than the size of a man's pinky, and resemble certain earthly woolie caterpillars, growing to be about 18 inches long. When they pupate they cocoon themselves to the undersides of tree branches. The grassilope that emerges is the size of an average house cat.

**Known Dangers:** Grassilope are not inherently dangerous, which is a pleasant surprise on New Horizon. However, large enough groups have been known to devastate carrot, onion, or potato crops.

**Eating Habits:** Grassilope maggots will eat any vegetation possible. As adults they prefer to dig up tubers and root stalks.

**Behavior:** Grassilope are extremely curious and seem to self domesticate. They are incredibly trusting towards anything that does not regularly prey upon them. As a result of this behavior, they make good pets for small children due to their cuddly and loving nature.

**Environment:** There is as least one variety of grassilope that calls each continent home. They are a major part in the moon's food chain as a base prey animal.
