Dear Judge Warne:

On May 8, 2017, you signed an Agreed Final Decree of Divorce in the above-reference case. Although the Decree disposed of the divorce proceeding between Wendy Meigs and Jody Meigs, the Decree did not dispose of the third-party action brought by Wendy Meigs against Jody Meigs, Michael Johnston, Francisca Lopez, Robin Luke, Scripts Pharmacy, Straden-Schaden, Inc., The Johnston Group, Inc. and Asyntria, Inc. The Decree specifically reserved these claims:

“P-22 Any and all claims that may exist in regards to the interest of **WENDY MARIE MEIGS** and **JODY NEAL MEIGS** in the entity known as Asyntria, Inc., including without limitation any and all claims against any of the third party defendants in this lawsuit, including but not limited to Michael Johnson, Scripts Pharmacy, Straden-Schaden, Inc. and The Johnston Group.” (emphasis in original)

However, it appears that the Clerk’s office has closed the file in error as if the Agreed Final Decree of Divorce disposed of all matters in this case.

On behalf of our client, Wendy Meigs, we respectfully request that you set her previously filed Motion for Summary Judgment for oral hearing on the earliest available date on your docket. Thank you for your attention to this matter.
