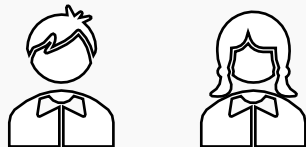

Equal Pay & Profit Share

- ✓ **Equal pay:** We are market leaders here - we pay all our lawyers (including the founder) 90% of their clients' billings (if they refer the work to someone else in the firm, they get 12.5% and the referred lawyer gets 77.5%). **This is the highest in the market.**
- ✓ Everyone gets an **equal share of the profits** (pro rata their billing). No one is allowed to profit from anyone else's work. **This is unique in the market.**



Flexibility & Diversity

- ✓ All our lawyers work flexibly (at client site or at home, or temporary offices, but basically **when and where** they want).
- ✓ We have **no billing targets**. Our view is that billing targets are a key factor to the enormous stress and negative health impacts on lawyers in our industry. Our **lawyers decide how much** they want to work.
- ✓ We specifically embrace and encouraging a **wide and diverse lawyer base** - initially our drive was to help mums back to work, now we deal with all the "isms" in the legal world that we see.
