# **PROPOSED Budget 2019-2020**



# **IMPORTANT INFORMATION**

Per State Law, the Limestone Community School budget approval process requires two steps.

**Step 1:** Every school system in the State is required to have a budget meeting where the Citizens will vote on each expense article. A final budget will be adopted at the end of this meeting. This will occur at the Annual Town Meeting on Wednesday, June 12, 2019 starting at 6:30 p.m. in the auditorium of the Limestone Community School, 93 High Street, Limestone.

**Step 2:** There will be a referendum to validate the budget approved. The referendum will be held on Thursday, June 20, 2019 and voting will be at the Limestone Town Office. The referendum question will be a “Yes” or “No” question.

**Article 1:** Do you favor approval for the Town of Limestone Community School budget for the upcoming school year that was adopted at the latest town meeting and that includes locally raised funds that exceed the required local contribution as described in the Essential Programs and Services Funding Act?

A “**YES**” vote allows additional funds to be raised for K-12 public education.

A “**NO**” vote means additional funds cannot be raised for K-12 public education.

**Article 2:** Do you wish to continue the budget validation referendum process in the Limestone Community School Department for an additional three (3) years?

A “**YES**” vote will require Limestone Community School Department to continue to validate its annual school budget for the next three years.

A “**NO**” vote will discontinue the budget validation referendum for at least three years and provide instead that the annual school budget shall be finally adopted at a meeting of the voters.

### **MESSAGE FROM THE LIMESTONE SCHOOL COMMITTEE AND ADMINISTRATION**

The Limestone School Committee and Administration is excited to be embarking on this long-awaited opportunity to return to an independent school district. We look forward to working with the excellent teachers and staff to ensure that the students are the top priority. The first year after withdrawal will be a year of rebuilding with challenges and opportunities but we are confident that there is a bright future ahead for Limestone Community School.

Although we're experiencing cuts to state subsidies and Title 1 funding, we are not alone. Most school systems in the area have experienced cuts to state subsidies. We also have the 1-time payment of \$150,000 to RSU 39 to complete our obligation for the new school construction in Caribou. We've worked diligently to develop a budget that helps establish a good foundation and we're confident that staff and administration can work together to build a successful future for the students at LCS.

As for opportunities, we have an obligation and desire to build a good relationship with MSSM. Therefore, it's crucial to have funds available to address items that have been neglected at the facility for several years. A team is being formed with representatives from both LCS and MSSM to identify and address facility concerns and create a successful partnership.

After very careful consideration, we are requesting \$250,000 from the school reserve to ensure continuity of the current programming, establish the groundwork for Limestone Community School and cultivate a partnership with MSSM. If we're able to allocate \$250,000 from the school reserve this will allow our team to continue with current programming, including art and music, and also address repairs and updates to the facility that are vital to building the partnership with MSSM. *If funding from the reserve fund is not provided then we will not be able to continue current programming or build for the future because there are other obligations that we must comply with during this first year.* It's important for the community to understand the need for the funds and to approve the use of \$250,000 from the reserve.

We recognize that the school reserve fund is diminishing and it's unfortunate that there is only about \$500,000 left but the town has continually used it over the last 20+ years to offset school taxes and many community members have assured us that we are justified in using it again this year because the sole purpose of the reserve fund is to benefit the school. Especially since we'll be getting our school back and ensuring a positive future for the children in our community. If other funding sources provide more than anticipated, then we can withdraw less than \$250,000 from the reserve and leave it for future use.

As for future viability, the Title 1 funding is expected to increase for 2020-2021 because the program will be using the 2019-2020 student numbers. We won't have any further payments to RSU 39 for the new school. The boiler payments of about \$113,000/year will end after 2 more years. Using funds from the school reserve, we're planning building modifications to save money, such as converting to LED lighting, adjustments to heating/leaking issues, cosmetic enhancements and more. We'll also be applying for grant opportunities.

We're committed to doing everything we can to make this endeavor a success and we welcome your support. The school is the heart of the town and if we lose the school, we lose our town. We must do everything in our power to make this a great school and encourage families to move to Limestone. We are faced with many opportunities to improve our school and our community. Let's not lose sight of the opportunities before us and the potential to do great things for the citizens of Limestone.

**ARTICLE 31 - REGULAR INSTRUCTION**

Article includes all regular Pre K-12 education. Teachers, ed techs and substitute teacher salaries and benefits are in this cost center. Classroom books and instructional supplies are also included here.

**ARTICLE 41:** To see what sum the Town will appropriate for the total cost of funding public education from Pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, (Recommend \$2,325,377.48), and to see what sum the Town will raise as the Town's Contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with Maine Revised Statutes, Title 20-A, section 15688.

Recommend: \$537,372.00

*Explanation: The Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a Municipality must raise in order to receive the full amount of state dollars.*

**ARTICLE 42:** (Written ballot required) To see what sum the Town will raise and appropriate in additional local funds.

(Recommend \$432,128.00), which exceeds the State's Essential Programs and services allocation model;  
(Recommend \$432,128.00) as required to fund the budget recommended by the School Committee.

The School Committee recommends \$432,128.00 for additional local funds and give the following reasons for exceeding the State's Essential Programs and Services funding model by \$432,128.00

STATE REASON: Tuition rate, Special Education and building maintenance.

*Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from Pre-Kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help achieve the Town budget for Educational programs.*

## **ARTICLES 43 & 44 SUMMARIZE THE PROPOSED SCHOOL BUDGET**

**ARTICLE 43:** To see what sum the Town will authorize the School Committee to expand for the fiscal year beginning July 1, 2019 and ending June 30, 2020 from the Town's contribution to the total cost of funding public education from Pre-Kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes. Title 20-A, section 15690, unexpended balances, tuition receipts, state Subsidy and other receipts for the support of schools.

Recommend: \$3,413,362.85

**ARTICLE 44:** In the event that the Limestone Community School receives more state education subsidy than the amount included in its budget, shall the School Board be authorized to use all or part of the additional state subsidy to increase expenditures for school purposes in cost center categories approved by the School Committee, and/or decrease the local cost share expectation, as defined in title 20-A, section 15671-A(1)(B), for local property taxpayers for funding public education as approved by the School Committee?

## **ARTICLES 45 & 46 RAISE AND APPROPRIATE FUNDS FOR THE SCHOOL NUTRITION PROGRAM**

**ARTICLE 45:** Shall the Town raise and appropriate \$1000.00 for the school nutrition program with Authorization to expend any additional, incidental, or miscellaneous receipts in the Interest and for the well-being of the school nutrition program.

**ARTICLE 46:** In addition to amounts approved in the preceding articles, shall the School Committee be authorized to expend such other sums as may be received from federal or state grants, programs or other sources during the fiscal year for school purposes, provided that such grants, programs or other sources do not require the expenditures of other funds not previously appropriate?

## **ARTICLE 47 RAISES FUNDS FROM THE SCHOOL RESERVE ACCOUNT FOR THE PROPOSED SCHOOL BUDGET**

**ARTICLE 47:** To see what sum the voters of Limestone will vote to transfer from the SCHOOL REFUND TOWN RESERVE ACCOUNT to be used to benefit the school.

Selectpeople Recommend: \$250,000

School Committee Recommend: \$250,000

*Explanation: This transfer will offset the additional cost of Limestone withdrawing from the RSU, including a one-time payment of \$150,000 and a shortfall in ED 279 funds from the state in the amount of approximately \$200,000.*
