This can then allow the bank to raise additional funds through rehypothecation on the property apart from the mortgage which they securitise a few months into payment. The mortgage could have been sold, transferred or assigned to third party. The process the banks followed is flawed. In avoiding taxes the banks paid off the mortgages and didn't pay SDLT stamp duty land tax to HMRC.
