



# 40th Annual NEWPORT CLASSIC YACHT REGATTA Presented by IYRS

# **NOTICE OF RACE**

The 40th Annual Newport Classic Yacht Regatta presented by IYRS (NCYR) is part of the Classic Yacht Owners Association Classic Yacht Series which also includes The Nantucket Regatta (Nantucket, MA), The Nantucket Opera House Cup Regatta (Nantucket, MA), The Corinthian Classic Yacht Regatta (Marblehead, MA), and The Herreshoff Classic Yacht Regatta (Bristol, RI).

NEWPORT, RHODE ISLAND

August 31-September 1, 2019

#### 1. ORGANIZING AUTHORITY

1.1. The Organizing Authority (OA) is the Ida Lewis Yacht Club.

#### 2. RULES

- **2.1.** The regatta will be governed by the rules as defined in the Racing Rules of Sailing and the 2019 Classic Yacht Owners Association Classic Yacht Series (CYOACYS) Series Regulations.
- 2.2. The Class Rules of designated one design classes.
- **2.3.** For the purposes of rules 14 and 44.1, any contact between boats shall be considered serious damage. This changes rule 44.1.
- **2.4.** In the event of a conflict between this Notice of Race (NOR) and the Sailing Instructions (SIs), the SIs shall prevail. This changes rule 63.7.

#### 3. ADVERTISING

- **3.1.** Advertising will be permitted in accordance with ISAF Regulation 20 and One-Design class rules as appropriate.
- 3.2. Participants may be required to fly sponsor flags as provided by the OA.

#### 4. ELIGIBILITY

**4.1.** The regatta is open to boats with a valid <u>Classic Rating Formula Mark II</u> (CRF MkII) rating certificate, a copy of which must be submitted to IYRS to validate entry.

Spinnakers will be allowed for all divisions.

- **4.2.** Spinnaker and Non Spinnaker (CRF MKII) designations must be declared no later than 1700 hours on August 29, 2019 by sending the declaration to the address(s) in Paragraph 4.1. Boats registering after the above date, or not declaring by the due date stated above, shall be entered using their Spinnaker handicap.
- **4.3.** Boats that are assigned to the same division, irrespective of their election to sail as Spinnaker or non-spinnaker, shall race as the same division. The declaration as Spinnaker and Non Spinnaker shall determine the boat's handicap factor within the division.
- **4.4.** Boats that compete in OA approved One-Design or Formula (Metre) classes are not required to produce a CRF MKII certificate.
- **4.5.** Five boats are necessary to constitute a class. The OA reserves the right to make exceptions and/or consolidate classes into a mixed fleet start to expedite racing.
- **4.6.** If a competitor wishes to modify the CRF Mark II rating submitted to the Organizing Authority (OA) as part of the original registration process, a written request shall be made to the OA prior to 1800 on Friday, August 30, 2019; unless the modification is to change between Spinnaker and Non-Spinnaker, in which case the deadline is specified in Paragraph 4.2 above. Any challenge to a rating posted on the preliminary scratch sheet shall be made to the OA by 1800 on Friday, August 30, 2019.
- **4.7.** Entries that would be characterized as "Day Racers", ie 6 mR's, Luders 24's, R boats, etc. may enter either as Day Racers or as regular fleet racers (Vintage or Classic depending on which age category they qualify for). The Day Racer fleet will sail on a short course and can anticipate two to three races per day. The Vintage, Classic, Modern Classic and Spirit of Tradition fleets can anticipate sailing one navigator race per day.

#### 5. ENTRY

- **5.1.** Eligible boats must register by completing online registration at <u>Newport Classic Yacht Regatta</u>.
- **5.2.** The entry fee prior to July 31 is \$9/ft (LOA). The entry fee as of or after August 1 is \$11/ft (LOA).
- **5.3.** The entry fee is refundable (minus a \$25 handling fee) if notice of cancellation is received by IYRS prior to August 23.
- **5.4.** Awards dinner tickets may be purchased for a price of \$50/ person online at Newport Classic Yacht Regatta. Please note that **no dinner tickets are included in registration fee**. Advance reservations are required.
- **5.5.** A liability waiver, available online at <u>Newport Classic Yacht Regatta</u>, or at registration, shall be submitted for each yacht no later than 0930 on Saturday, August 31 and shall be signed by each crew member. Yachts are encouraged to complete waivers online or emailed to

<u>events@iyrs.edu</u> prior to 1800 on Friday, August 30. **Yachts without properly signed waivers may not be scored.** 

In the event of a crew substitution, the new crew member shall submit a signed waiver to Race Headquarters at the IYRS campus prior to racing.

#### 6. RACE HEADQUARTERS

**6.1.** The Race Headquarters will be at Restoration Hall at IYRS School of Technology & Trades at 449 Thames Street, Newport, RI.

- **7.1** Two races (one per day) are scheduled for the yachts competing in the CRF portion of the Newport Classic Yacht Regatta. Please see the addendum for the Division designation. Sub Division (class splits) will be assigned and published at registration.
- **7.2** Up to three races may be completed on each day of racing for One-Design and Formula classes.

#### 8. MEASUREMENT

- **8.1.** Yachts must submit a valid <u>CRF MKII</u> rating certificate for their given division outlined in the CYOA Series Regulations.

#### 9. SAILING INSTRUCTIONS

**9.1.** SIs and class assignments will be available at or before the Mandatory Skippers' Meeting held in Restoration Hall at IYRS at 0930 on Saturday, August 31.

#### 10. RACING AREA AND COURSES

**10.1.** The regatta will be sailed in Narragansett Bay and Rhode Island Sound. The Race Committee will designate courses using government marks and inflatable marks as specified in the SIs.

#### 11. PENALTY SYSTEM

**11.1.** The Scoring Penalty, RRS 44.3 will apply. However, when a yacht may have broken RRS 31 but not a Rule of Part 2 in the same incident, the Scoring Penalty percentage shall be 10%.

**11.2.** The Protest Committee may impose suitable penalties, other than disqualification for violations of the Class Rules, or other non Part I or Part II rules of the RRS.

#### 12. SCORING

- **12.1.** One completed race constitutes a series.
- 12.2. A boat's series score will be the total of all her race scores. This alters rule A2.
- 12.3. Handicap classes will be scored based on CRF MKII ratings.
- **12.4.** Spinnaker and Non Spinnaker boats in the same division shall be scored as a single division.
- **12.5.** One-Design and Formula classes will be scored level
- **12.6.** Boats eligible for the CYOA Series will be scored in accordance with <u>CYOA Series</u> <u>Regulations.</u>

#### 13. PRIZES

- 13.1. Racing awards will be presented at the Sunday night awards reception.
- **13.2.** Prizes will be awarded to the regatta and overall series winners of the CYOA in the scoring divisions as outlined in the <u>CYOA Series Regulations</u>.
- **13.3.** Other awards may be presented at the discretion of IYRS and their sponsors based on criteria other than scores.

#### 14. SAIL AND EQUIPMENT LIMITATIONS

- **14.1.** Yachts competing in the IYRS Newport Classic Yacht Regatta will have sail and equipment limitations as outlined in <u>CYOA Series Regulations</u>.
- **14.2.** Spinnakers will be allowed for all divisions. However, both spinnaker and non-spinnaker boats will compete in the same division.
- **14.3.** Class rules regarding sail and equipment limitations will apply for any One-Design and Formula classes

#### 15. DOCKAGE AND MOORING

**15.1.** Participants may make arrangements for dockage by contacting the following directly:

#### 16. RADIO COMMUNICATION

- **16.1.** All boats shall carry with them a radio capable of making and receiving VHF transmissions.
- **16.2.** Except in an emergency, a boat shall neither make nor receive radio transmissions not available to all boats.

#### 17. INSURANCE

**17.1.** Each boat shall hold adequate insurance (including third-party liability insurance of \$1 million per incident). It is the boat owner and/or the person in charge's inescapable responsibility to ensure that the insurance is valid and adequate prior to participating in this event.

#### 18. MEDIA RELEASE

**18.1.** Competitors and crew members on the competing yachts grant, at no cost, IYRS, Ida Lewis Yacht Club, regatta photographers and affiliated companies the absolute right and permission to use their name, voice, image, likeness, biographical material and representations of the boats in any media world-wide (including but not limited to television, video, print and electronic media), for the sole purposes of advertising, promoting, reporting and disseminating information regarding the 40th Annual Newport Classic Yacht Regatta and all participants therein.

#### 19. DISCLAIMER OF LIABILITY

Sailing is an activity that carries with it an inherent risk of damage and injury. Competitors participate in this regatta entirely at their own risk and are reminded to pay special attention to rule 4, Decision to Race. The race organizers including the OA, Race Committee, Protest Committee, the State of Rhode Island, sponsors, volunteers, or any other affiliated organization or official will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of practice or participation in this event in both shore-side and on-the-water activities. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
