In the News:

State Shifted Medicaid Expense between Fiscal Years by Delaying Payments 3 Days:

NYS shifted \$1.7B in Medicaid spending from FY2018-2019 into FY2019-2020 by delaying Medicaid payments from the last week of March until the first week of April. This was prompted by the statutory cap on increases in year-over-year

Medicaid spending. The shift was NOT prompted by a shortage of cash. The state reports a surplus of \$12 billion for FY2018-19. Questions remain as to how the state will address this shift at the end of FY2019-20. Will it cut Medicaid rates? Shift payments into the next fiscal year? Ignore/amend the cap on spending increases?

UnitedHealth Needs to Shore up Mental Health Coverage, Plaintiffs Argue:

Plaintiffs in a class-action lawsuit are claiming that United Health Group should create new guidelines for covering BH treatment and evaluation and should use those new guidelines to re-evaluate previously denied claims.

The plaintiffs made this rebuttal following a decision in the Northern District of California that United Behavioral Health violated its responsibilities to its members by denying mental health and substance use treatment as a cost-savings measure.

Key take aways: 1) It would create a "Medicare-ish" public option; 2) Would create a premium-free Medicaid option for adults in non-expansion states; 3) Would increase tax credits for purchasing health insurance; 4) Prohibits "surprise billing" for out-of-network services provided at in-network facilities; 5) Medicare would be allowed to negotiate prices and terms with pharmaceutical companies; 6) Drug prices could not be increased any faster than the general inflation rate, and; 7) Repeal of the Hyde Amendment.

Chief Clinical Officer (CCO) Report:

We've been busy here at CBHS!

Through our partnership with Hudson River HealthCare as CBHCare and as part of the level 2 VBP contract we have with MVP Health Care we are launching a new data analytic platform that will enhance our abilities to coordinate care, stratify risk, target interventions, and track our performance.

CBHS is working with Health Management Associates to build our interim CBHS data exchange platform. The interim CBHS data exchange platform will help increase our access to network-wide census and service utilization data that will ultimately be connected to the larger data analytic platform that CBHS is developing. And it will be cross walked with other data sources such as PSYCKES, the Health Information Exchanges, and MCO claims data.

CBHS has also been busy in its work with our partners at Montefiore, as we continue to engage with MHVC on an upcoming innovation pilot project. We are also taking steps forward on the NG ACO, including scheduling quality improvement meetings with key CBHS agencies and developing a proposal for integrated behavioral care at PCP sites. And, CBHS has made progress on the Small PCP project.

As the Transition of Care and Wellness Program moves forward into its second year, CBHS and its partners help hundreds of clients make a smooth transition from the inpatient mental health units into person-centered outpatient treatment and community supports and services as needed. We thank our partners in this project at PEOPLe, Inc., Independent Living, Family Services, Inc., MHA Westchester, and Access, as well as, our partners at Bon Secours and Mid-Hudson Regional Hospital for their continued support.

And lastly, the Quality Oversight Committee (QOC) continues to do vital work. This past month, we restructured the committee to be more streamlined and efficient. Our new Polices and Procedures were approved by the CBHS Board. We took a huge step towards finalizing our workflows targeting out "Top 3" metrics (Diabetes Screening for people with Schizophrenia or Bipolar Disorder using anti-psychotic medications, Follow-Up After Hospitalization for Mental Illness, and Engagement in Alcohol & Other Drug Abuse or Dependence Treatment). We also outlined our Performance

Enhancement Plan (PEP) and we will launch our first waves of dialogue meetings in the next few weeks. PEP meeting will be available to all members and affiliates.
