WAIVER AND INFORMED CONSENT TO PARTICIPATE IN EQUESTRIAN ACTIVITIES

I, the undersigned, having read and understood the content of this document, agree and consent to the provisions contained herein. It is my intention and desire to participate in equestrian-related activities including but not limited to carriage driving over rough terrain, riding, horse-handling, ground crew, or being present at equestrian activities as an observer, volunteer, parent, or other activity related, however slight, to equestrian activities at events held at 33222 Roehen Road (Zadow Property), in Waller, Texas. I hereby acknowledge that I am fully aware of the nature, purpose and risks of equine activities. I acknowledge that these activities are potentially dangerous and that I voluntarily accept any of the inherent risks involved. In consideration for my being permitted to take part in these activities, I agree to be bound by the rules of the Zadow Property in Waller, Texas and to obey the directions of the owners, trainers and other governing officials of activities. I agree to release, hold harmless, and keep indemnified Zadow Property, Zadow Air, Claire & Ryszard Zadow, and their trainers, employees, organizers and agents, officials, servants, volunteers, employees and representatives and owners of any properties used for Waller downs Witch Hunt 2019, including but not limited to Claire & Ryszard Zadow (collectively, the “Property Owners”) from and against all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to my person or property, howsoever caused, arising out of or in connection with my taking part in these events even if the same may have been contributed to or occasioned by the negligence or gross negligence of Zadow Property, or any of their owners, trainers, volunteers, employees, agents, servants, or representatives or Claire & Ryszard Zadow, the Property Owners.
