Infradebt is looking for a female final-year undergraduate student to work as a paid intern in its Canberra office in 2019. The position is open to students who expect to complete their university studies at the end of 2019.

Infradebt's clients range from some of Australia's largest superannuation funds, through to family offices and foundations. The firm's approach focuses on selecting investment opportunities based on a deep understanding of the project, the infrastructure sector in which it operates (renewables, ports etc) as well as broader macroeconomic conditions.

A core tenant of the firm's capability is genuine collaboration and diversity of thought and ideas contributing towards the final investment thesis. Thus, building the diversity of the firm's investment team is an important component of firm's long-term strategy. This internship is part of this strategy.

Role Description

The successful candidate will be involved in the initial due diligence of investment opportunities and ongoing asset management of project finance loans. They will also contribute to Infradebt's broader sector research and analysis of the Australian infrastructure market. Work would include both quantitative (excel based) and qualitative analysis.

This is a unique opportunity to get hands on experience in project finance and infrastructure investing. As part of a small team, you will gain exposure to all facets of investment portfolio design, construction and management. You will also work closely, and be supported by, a range of very experienced investment professionals.

The role is part-time (indicatively 8-10 hours per week) for calendar 2019. Subject to the performance of the selected candidate, and the resource requirements of the firm, the intention would be for the candidate to transition into a full-time position with the firm post-graduation.

Infradebt is an equal opportunity employer, and as part of this approach we provide flexible working arrangements for all staff. In particular, responsibilities and hours in calendar 2019 would be designed to be complementary to the candidate's university obligations.



Candidate Characteristics

- Currently undertaking university study in finance/economics/actuarial studies
- Have a genuine interest in project finance and fixed income markets
- Strong written and verbal communication skills
- Strong quantitative skills particularly in Excel
- Australian citizen or permanent resident with an intention to live and work in Canberra on a medium-term basis;
- Strong attention to detail; and
- Analytical, curious (and sceptical) mindset with a capacity to work effectively in a team.
