### \*\*\* SUPPLIER LIEN RELEASE POLICY \*\*\*

1. <u>Before a pay request can be processed and a check issued</u>, we must receive either unconditional (paid) or conditional (unpaid) lien releases (exhibit F) from ALL suppliers from whom you have purchased materials, rented equipment, or subcontracted out services during the <u>period</u> for which the pay application covers.

<u>These supplier releases should be submitted for ALL pay applications (first through the last, as well as change orders billed separately.)</u>

If we receive a conditional lien release, Maxx Builders & Designers Inc. will (at Maxx Builders & Designers Inc. sole discretion and election) make payment jointly to Subcontractor and any one or more of its suppliers and/or subcontractors.

- 2. Before you will be issued payment on your next month's pay application, if joint checks were issued on the previous pay application; we must receive <u>unconditional supplier lien releases</u> from that joint check, and we must receive <u>unconditional releases</u> from the subcontract for previous period.
- 3. If there were NO suppliers and/or subcontractors for the current pay application, you will need to state that on your letter head; for that job; for that pay period.
- 4. Prior to releasing final payment, we will require a final lien release from all vendors/suppliers. If unconditional lien release is not provided, the check will not be released.

Attached are blank forms for unconditional (paid) and conditional (unpaid) lien releases for your use with your suppliers.

This release covers a progress payment for labor, services, equipment, or material furnished through the pay application for only (herein the "Release Date"), and does not cover any retention retained before or after the Release Date, extras furnished before the Release Date for which payment has not been received and extras or items furnished after the Release Date.

Rights based upon work performed, items furnished or extras under a written change order which has been fully executed by the parties prior to the Release Date are covered by this release unless specifically reserved by the claimant in this release. Except as set forth herein, this release of any mechanic's lien, stop notice, or bond right shall not otherwise affect the contract rights, including rights between parties to the contract based upon a rescission, abandonment, or breach of the contract, or the right of the undersigned to recover compensation for furnished labor, services, equipment, or material covered by this release if that furnished labor, services, equipment, or material was not compensated by the progress payment. Before any recipient of this document relies on it, said party should verify evidence of payment to the undersigned.

### □ UNCONDITIONAL LIEN RELEASE AND WAIVER

The undersigned has been paid and received, in full, the sum of charges for labor and services, equipment, or materials furnished to the Contractor, Owner or Subcontractor on the above described Project. The undersigned does hereby release pro tanto any mechanic liens, stop notice or bond rights that the undersigned has on said Project or against such Contractor, Owner, Subcontractor and surety of any payment or performance bond issued in regard to the Project through \_\_ (herein the "Release Date") only and does not cover any retention or items furnished after the

### Release Date.

By selecting and signing this Unconditional Lien Release and Waiver, the Undersigned does hereby waive all rights unconditionally and states that the Undersigned has been paid for giving up those rights. This document, once signed, is enforceable against the Undersigned even if payment has not been received.
