

## **ASSEMBLY RESOLUTION 7-013**

## A RESOLUTION TO SUPPORT SCOPE'S 4-POINT LIST OF REQUESTS FOR UNDOCUMENTED STUDENTS

**WHEREAS,** the Student Community of Progressive Empowerment (SCOPE) is a

student organization operated by and for undocumented students on

campus; AND

**WHEREAS**, undocumented immigrants and families across the United States today

face anti-immigrant rhetoric that disrupts the daily lives and experiences

of undocumented students on the U-M campus; AND

**WHEREAS**, undocumented students have felt the implications<sup>1</sup> of recent federal

decisions to end the Deferred Action for Childhood Arrivals (DACA) program, which supported opportunities for hundreds of thousands of

undocumented students to pursue higher education;<sup>2</sup> AND

WHEREAS, University administrators<sup>3</sup> and Central Student

Government<sup>4</sup> have released statements to voice their firm disagreement with the decision to eliminate DACA, and to support undocumented students who have earned their place at the university, regardless of

citizenship status; AND

**WHEREAS,** in its Diversity, Equity, and Inclusion (DEI) strategic plan, the University

repeatedly outlines its commitment to broader efforts of equity and

inclusion, emphasizing diversity as a resource that can be leveraged "to

advance our collective capabilities"<sup>5</sup> and promising to "work to equip individuals with the support and opportunities necessary for their success";<sup>6</sup> **AND** 

**WHEREAS,** SCOPE has compiled a 4-point list of requests of the University that offer direct solutions and resources to institutionally meet some of the needs of the undocumented student community; <sup>7</sup> **AND** 

**WHEREAS**, the first request is for increased financial support from the Office of Financial Aid, in the form of scholarships for undocumented students whose financial needs are otherwise unmet; **AND** 

**WHEREAS**, the second request is for an expansion of the strict and time-sensitive guidelines for obtaining in-state tuition that currently impose unrealistic standards on undocumented students during the application process; **AND** 

**WHEREAS**, this request was previously addressed and supported by the Fifth Assembly of the Central Student Government;<sup>8</sup> **AND** 

WHEREAS, the third request is for the appointment of a primary staff contact who will act as a liaison between the undocumented student community and the University administration, ensuring that no information is lost between them and all resources are made available to the undocumented student community throughout their academic career; AND

**WHEREAS**, the fourth request is for the implementation of more accessible outreach and recruitment efforts, beginning with a resource page on the University website to encourage undocumented prospective students to apply; **THEREFORE BE IT**
