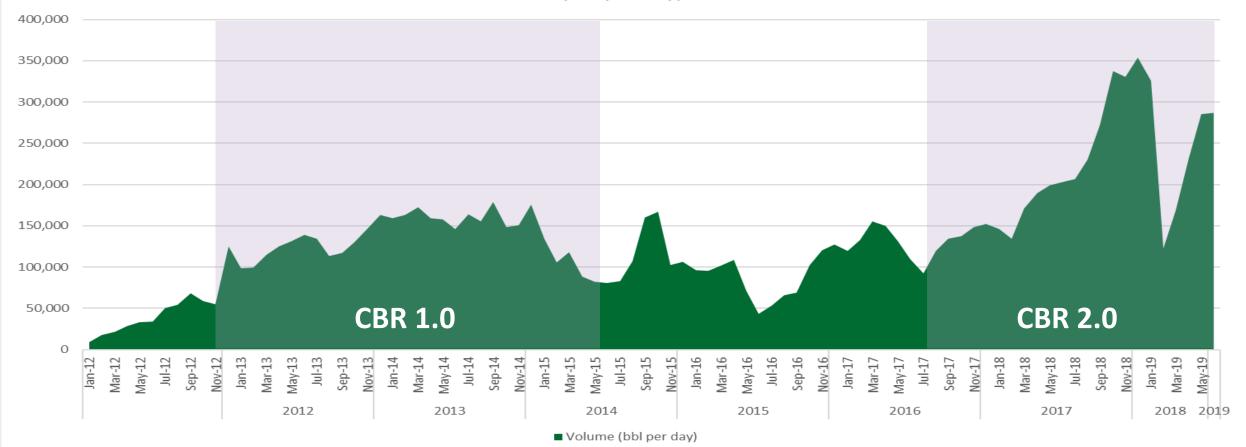

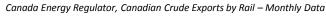

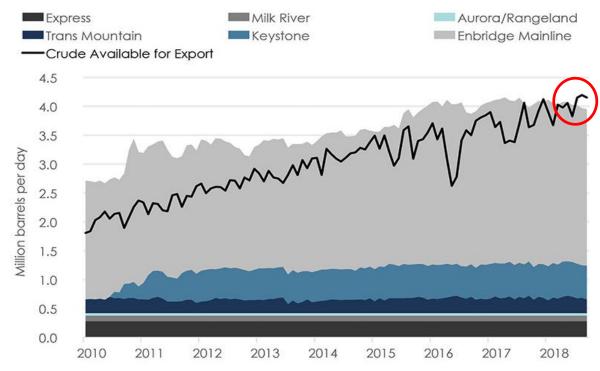

IMPACT OF PIPELINE APPROVALS & DELAYS

Constrained Pipeline Capacity

- Western Canadian production outstrips pipeline capacity by 350,000 barrels per day¹
- TMX, KXL and Enbridge Line 3 expansion projects will alleviate that pipeline capacity issue when completed
- Moving undiluted heavy crude improves take away efficiency by as much as 50% by eliminating the transport of diluent

CBR VALUE TO GULF COAST REFINERS

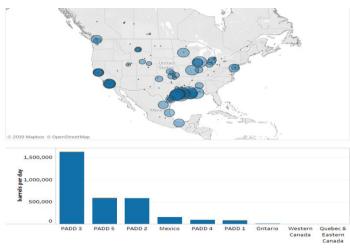
Gulf Feedstock

- High wax content in crude grades lead to unplanned maintenance within refineries
- Substantial light crude feedstock has resulted in excess light product, and not enough middle distillate crack splits
- These factors contribute to demand for heavy crude

Geopolitical Impact

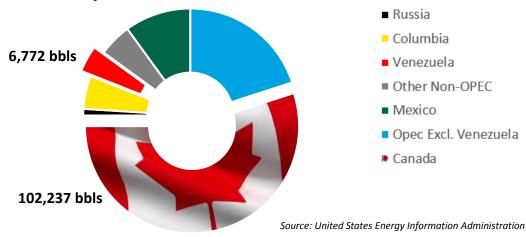
- Shortage of heavy crude due to Iranian sanctions, Venezuela upheaval, declining Mexican production, etc.
- Re-emergence of security risk with recent attacks on Saudi production

February 2019 - 186.2 Million bbls



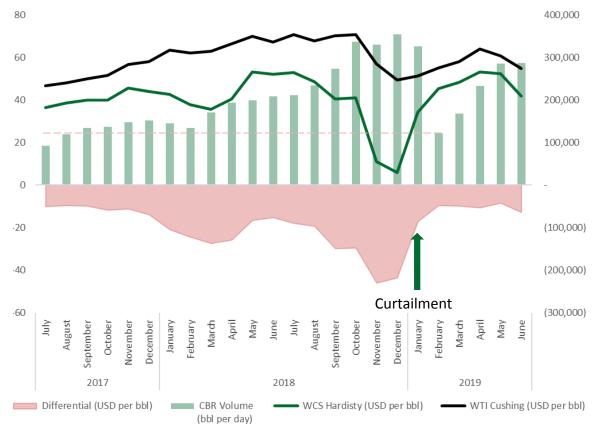

IMPACT OF GOVERNMENT INTERVENTION

Tightened Differentials

- Curtailment announced December 2, 2018 resulting in immediate tightening of WCS-WTI differentials
- January rail loading dipped to August 2017 levels in response to WCS-WTI differentials
- CBR recovery through Q2-2019 a result of increased pipeline apportionment overflow
- Current pricing relative to delivery, rather than the index differential.

CBR Efficiencies & Advantages

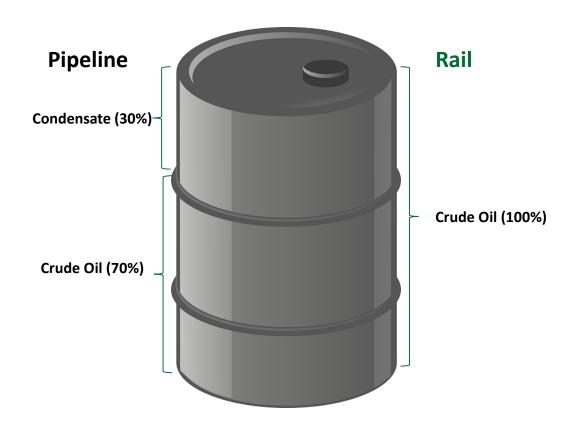
Pure product, grade integrity

- Pipeline batches pass through tankage in Patoka and Cushing pipeline hubs, resulting in unwanted blending of crude
- Crude by rail ensures that what is loaded into the car, is what is paid for, and delivered per the original specification

Timely delivery

- 110 cars can be filled with heavy crude in <24 hrs.</p>
- Six to ten days between departure and delivery versus 12-30 days by pipe

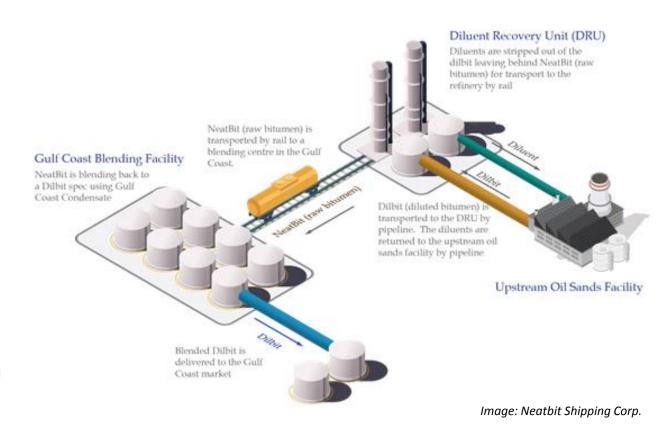
Undiluted Crude Efficiency

Benefits

- High-value middle distillate crack splits naphtha, kerosene, jet fuel, distillates
- Improved refining margins
- Non-hazardous material for transport higher flashpoint, lower environmental liability
- Reduced cost to deliver leads to greater realized pricing per produced barrel

Sources

- Trucked from wellhead
- Pipeline from production origin to hub, to utilize a Diluent Recovery Unit





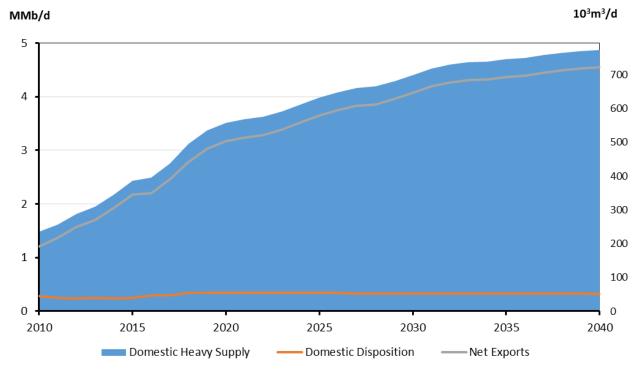
DRU NETWORK EFFICIENCY

Availability

- Steady growth in heavy oil production
- Existing crude by rail terminals
- Pipeline hubs deliver ample diluted heavy feedstock

Infrastructure Expansion

- DRU of requisite scale requires significant investment
- ROI achieved through reduced cost per barrel delivered to market, increasing realized netbacks

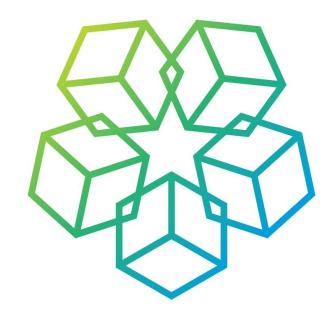
EVOLUTION OF CBR MANAGEMENT

Electronic Delivery Management

 Crude quality specifications and loaded volume recorded and added to a private blockchain.

Real-Time Train Car Management

- Crude tank car lid and location monitored by GPS for the duration of the move.
- Geo-fencing triggers create notifications to related parties when trains leave and arrive.
- Value creation comes from scheduling efficiencies, verifiable product integrity, and an auditable transaction log.
