

#### Study finds major brands selling cat food that contain protected sharks.

Researchers used DNA barcoding to find that cat food sold in Singapore from at least 16 different brands contained threatened species of sharks, including silky sharks (Carcharhinus falciformis) that are protected under CITES Appendix II. Leading brands such as Fancy Feast, Whiskas, and Sheba were amongst those found to contain silky sharks and other species.

Sites of Special Scientific Interest.

This year, as in all others, we follow the muddlings of Natural Resources Wales who look after their own sites in their usual contemptuous ways.




Horses grazing one 'protected' orchid site in April while sheep have access to an equally 'protected' site down the road from here. And nothing much had changed on a later visit there either.

Wind turbines' deadly toll on migrating birds: Map highlights 'collision hotspots' in Europe and North Africa where owls, swans and eagles are at highest risk of being killed by power generators' blades

University of East Anglia study identifies collision 'hotspots' for migrating birds

Many lie in the South of France, Southern Spain and the Moroccan coastline

They are particularly concentrated within important migration routes

Researchers say new developments should be minimised in these areas

They may be considered an eco-friendly way to generate energy, but wind turbines pose a major threat to migrating birds, which are at high risk of colliding with the giant blades while in flight.

Now a new study has identified the collision 'hotspots' where migrating birds such as owls, swans and eagles are most at risk of being killed by turbines or power lines.

The researchers have produced a map, revealing that birds are more likely to get too close to turbines and power lines on key migration routes, on the coast and at key breeding grounds.

Many such spots lie in Mediterranean regions including the South of France, Southern Spain and the Moroccan coastline – such as around the Strait of Gibraltar.

They are also vulnerable in Eastern Romania, on the Sinai Peninsula in Egypt and along Germany's Baltic coast.

The GPS data collected related to 1,454 birds from 27 species – mostly large soaring ones such as white storks.

'The use of high precision GPS devices allow us to study birds' movements in huge detail,' said Phil Atkinson, project supervisor from the British Trust for Ornithology

'Birds do not respect country boundaries and power lines and wind turbines impact migratory birds across their annual cycle, especially for large soaring birds such as raptors and storks.'

Exposure to risk varied across the species, with the Eurasian spoonbill, European eagle owl, whooper swan, Iberian imperial eagle and white stork among those flying consistently at heights where they risk colliding with infrastructure.

The researchers said development of new wind turbines and transmission power lines should be minimised in these high sensitivity areas, and any developments which do occur will likely need to be accompanied by measures to reduce the risk to birds.

'We believe it is the first time GPS tracking data from multiple species has been used in this way,' said lead author Jethro Gauld, a PhD researcher at UEA.

'Such measures can include marking power lines to make them more visible and implementing systems to allow shutdown of wind turbines during periods of high bird traffic.'

The academics acknowledge that transitioning to net zero by 2050 is essential if catastrophic climate change is to be avoided.

Onshore wind capacity in Europe is expected to be four times higher in 2050 than it is today, and countries in the Middle East and North Africa, such as Morocco and Tunisia, also have targets to increase the share of electricity supply from onshore wind.

## The Scottish Government has recently published its "Future Catching Policy", calling it a "world leading fisheries proposal".

Whilst we welcome the proposals that suggest "spatial management" may be used to avoid areas where lots of bycatch is caught and subsequently discarded, the proposals also say "[f]or undersized fish (i.e. below MCRS), we propose allowing discarding" and for inshore trawlers (i.e. those operating in the sea lochs, sounds and firths around Scotland's coastline) an additional exemption that "we intend to introduce an exemption for discarding whitefish [cod, haddock, whiting, etc] bycatch on the basis of disproportionate cost". With these words, the Scottish Government are effectively seeking to undo key EU law aimed at preventing the wasteful (and destructive) practice of discarding fish.

This is a very bad policy.

The ban on discarding was established in 2013 by the EU, it was gradually incorporated into law to allow fishers time to adjust, and quotas were significantly increased to counteract the fact that those businesses bycatching lots of fish would need to land it. It was established to prevent the food and ecosystem waste caused by catching unwanted species and ages (i.e. young and unmarketable) of fish. The whole point of requiring that it be landed was that it would disincentivise catching it in the first instance.

Over the past nine years, the Scottish Government has made some serious errors in delivering the discard ban: the quota increases were gifted to fishermen without condition (e.g. that cameras be fitted to ensure that discarding actually stop) and adequate enforcement of the rules has been severely lacking. The result - discarding has continued and significantly added to overfishing. Now, having failed to deliver the policy which was supported at the time by some 800,000 signatures, the new SNP/Green coalition government appears to be trying to remove key parts of the ban entirely.

We consider the proposal to allow discarding of juvenile fish particularly egregious these are the future of our fish populations (and the fish on our plates). To allow them to be caught, killed in the net and then thrown away is literally taking food away from future generations.

At a time of food insecurity, and during a twin biodiversity and climate crisis, there can be fewer worse policies to be proposing, but it is here in black and white. We plan to challenge this, and will need your help to do so. Watch this space for things you can do to assist.

## THE WASTEWATER DISASTER IN FLORIDA IS A SYMPTOM OF HOW WE GROW OUR FOOD

Fearing a 20-foot "tidal wave" of contaminated wastewater breaking free from a giant industrial waste pile, Florida officials told hundreds of residents to evacuate their homes in Manatee County over Easter weekend.

Since then, authorities have furiously drained more than a 170 million gallons of wastewater to alleviate the pressure that might have otherwise overwhelmed containment walls. The most dangerous water (which picked up contaminants as it leaked through the breach) was trucked away to be processed — but the rest has been intentionally drained into Tampa Bay, where it could cause more problems.

## DISASTERS THAT CAN BE TRACED BACK TO THE AREA'S LEGACY OF MINING PHOSPHATE ROCK

It's a string of potential disasters that can be traced back to the area's legacy of mining phosphate rock, which the agricultural industry relies on for fertilizer. The crisis is unfolding at the former Piney Point phosphate plant, where phosphate was mined and then turned into fertilizer for decades until the site was abandoned in 2001. What's left in its wake are three towering phosphogypsum "stacks" — flat-topped hills of radioactive industrial waste with wastewater ponds at the center.

This isn't the first time phosphogypsum stacks have suddenly released slurries of water and waste — and it probably won't be the last. Another crisis like the one at Piney Point could easily happen again unless we rethink the way we grow our food, some environmental advocates say.

"The damage that occurs from just producing fertilizer — not even using it, but just producing fertilizer — is profound," says Rachael Curran, an environmental attorney in Florida.

#### A BIG MESS

Florida supplies a quarter of the world's phosphate and 80 percent of all the phosphate used in the US. Most of it goes into fertilizer.

But before it can be used to help crops grow, the phosphate goes through a chemical process that leaves behind a big mess. Once phosphate ore is dug up, sulfuric acid dissolves it into a "slurry." The stuff used in fertilizer is separated out from the slurry, leaving behind phosphogypsum as a byproduct. For every ton of desirable phosphoric acid produced for fertilizer, more than five tons of phosphogypsum waste remains.

Phosphogypsum has been used as a construction material in other countries, like China, which produces the most phosphate in the world (the US ranks third). But in the US, the Environmental Protection Agency banned using the material in construction in 1989 because of its radioactivity, albeit at relatively low levels. (Phosphate ore contains some uranium, thorium, and radium.)

Last year, the EPA gave the greenlight to use phosphogypsum with low levels of radioactivity to build roads (it followed a landslide of environmental rollbacks under the Trump administration). But Curran still worries about that — instead of piling the risk all in one place, she worries, that's just spreading it around.

Since it isn't typically used for anything, the phosphate industry pumps its leftover "slurry" into phosphogypsum stacks. Water pools on the top while solids settle and are used to form the containment walls. These "stacks" grow into mountains over time — with some reaching nearly as tall as a 20-story building and as wide as 600 football fields. There are more than two dozen phosphogypsum stacks strewn across Florida.

Fogging is a technique used for killing insects that involves using a fine pesticide spray (aerosol) which is directed by a blower. In some cases a hot vapour may be used to carry the spray and keep it airborne for longer. Fast acting pesticides like pyrethroids are typically used. This is widely used for sampling or studying insects in the canopy of tall of forests which cannot be effectively reached. The floor below the trees are lined with plastic sheets and the fog causes insects to fall in a rain. These are collected for later study in the laboratory.



The Government takes a share of every energy bill to fund cutting decarbonisation efforts

Green and social levies on energy bills will cost households more than £150 a year from April, representing 8pc of the total bill.

Energy bills have soared thanks to a rise in wholesale prices. In February 2022, regulator Ofgem announced that the average home on a default tariff will pay £1,971 for their energy from April.

Some £153 of this will be made up of environmental and social obligation costs levied on suppliers by Government. Currently the levy stands at £159.

These levies help fund energy efficiency improvements and renewable projects, as well as social schemes such as the warm home discount.
