3. The Donated Dental Service Program is still looking for more volunteers, both general dentists and specialists. The program enables dentists to reach out to New York's most vulnerable residents – elderly, disabled and medically compromised people – who desperately need comprehensive dental care that they cannot afford. All patients are prescreened for eligibility and the volunteer dentist is never under any obligation to accept referred patients. The dentist determines the treatment plan and no extra paperwork is produced for the office staff. Funding for the program has been cut out in New York State but the city program is still in effect and the waiting list is growing.
