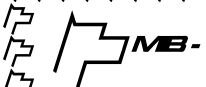

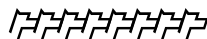

AKC Canine Good Citizen & Trick Dog Testing

Testing will be available on Saturday & Sunday. Testing will be conducted in the lobby and exterior of the Hampton Roads Convention Center starting at the show lunch break. Please sign up early at the Trophy Table as entries will be limited. Cost is **\$15.00 CASH** per test. If dog already holds CGC title and is testing for CGCA, CGCU or Tricks Novice, owner must provide a copy of AKC Title Certificate. See specific information below. All dogs to be tested must be current on vaccinations.

Saturday - Testing for AKC CGC, CGCA and CGCU:

Consult AKC website for descriptions of ten (10) exercises that will be tested for CGC, CGCA and CGCU titles. Some exercises will be tested individually and others in groups. Owners should be knowledgeable about appropriate collars and leashes. No treats may be used during the actual test. Limit is 20 dogs total.

Sunday Testing for AKC Trick Dog TKN, TKI and TKA:

Owner should provide printout of application and respective checklist for title to be tested. These may be found at AKC website listed below. No test equipment (hoops, balls, boxes, crates, etc.) will be provided by LKC. Owners should bring their own equipment if needed. However, no agility type equipment (weave poles, etc.) will be allowed in HRCC lobby. Owners should be knowledgeable about appropriate collars and leashes as well as rules on testing and/or luring at each Trick Dog level. Each dog will be tested individually. Limit is 12 dogs total.

Heading West on I-64 (From Norfolk): Take exit 263 (W. Mercury Blvd./Hampton Coliseum) and turn right at the end of the ramp. Continue straight until the first traffic light and turn right onto Coliseum Dr. Go approximately ¼ mile. Turn left onto Pine Chapel Rd., the HRCC is on your right.

Heading East on I-64 (from Richmond): Take exit 263 (Mercury Blvd./Hampton Coliseum). Continue straight for approximately ¼ mile to Coliseum Dr. Turn right onto Coliseum Dr. and go approximately ¼ mile. Turn left onto Pine Chapel Rd., the HRCC is on your right.

FOR UNLOADING, PARKING & RV AREA - The HRCC loading dock will be one block on your right. Parking is past the building on your right.

Notice to Exhibitors - General Information

Show grounds will be available at 3:00 P.M. Wednesday and must be vacated immediately following Best in Show on Monday.

Dog-wash area will be located at the loading dock. Exhibitors bring own supplies.

Private Exercise Pens are NOT permitted indoors (this includes using exercise pens as crating).

Private Exercise Pens ARE permitted in designated grass areas adjacent to the loading docks and in the parking areas. If sawdust is used in x-pens, plastic must be placed under & up the sides. Please clean up.

Grooming/crating permitted in designated areas only.

There will be no space for unentered dogs, except those attending clinics or special attractions.

Crating/Grooming

Day Grooming **MUST** be cleared each day one hour after Best in Show. Equipment left in this area will be removed.

Dogs entered in the events will be permitted to remain in the building overnight Wednesday through Sunday, but must be removed after Best in Show on Monday. The building will be locked from 10:00 P.M. until 6:00 A.M. during the show period.

NO flexi-leads allowed in the building.

NO DOGS PERMITTED IN FOOD CONCESSION AREAS OR PUBLIC RESTROOMS.

AKC Sanctioned 4 & Under 6 Months Puppy Competition

Entry Fee: \$27.00 per puppy

One combined class will be offered for breeds and varieties of dogs that are (4) four months & under (6) six months and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. **There will be a selection of Best 4 & Under 6 Months Puppy in each Breed/Variety**, each Best 4 & Under 6 Months Puppy in Breed/Variety winner will then compete in their respective group for First through Fourth Placements. The Miscellaneous Class Competition will be judged same as above followed by a Miscellaneous 4 & Under 6 Months Puppy Group Competition. The Foundation Stock Service Class Competition will be judged same as above followed by a FSS 4 & Under 6 Months Puppy Group Competition. All First Place Group Winners will be eligible to compete in Best 4 & Under 6 Months Puppy in Show.

An AKC registration number or AKC litter number will be required for entries of an AKC recognized breed or Miscellaneous breed. FSS number or FSS registered litter number will be required for FSS entries.

A foreign born dog may enter this class if they are registered in the country of origin.

Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs to or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.*

AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise. Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Show Competition.

AKC National Owner-Handled Series (Remember to check the box near the bottom of the entry form)

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

**A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.
