### **Notice of Race**

#### **1.0 Rules**

- 1.1 The regatta will be governed by the 'rules' as defined in the *Racing Rules of Sailing*.
- 1.2 The YNZ Safety Regulations Part 1 shall apply.
- 1.3 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located at the Worser Bay Club Rooms.
- 1.4 Appendix T, Arbitration, will apply.

#### **2.0 Eligibility and Entry**

- 2.1 The Tanner Cup Trial is open to all P Class boats registered in the name of the current owner, comply with the class rules and whose skippers are under 17 years of age on 31 January 2020 and who have been a financial member for the three months prior to the regatta of a yacht club affiliated to Yachting New Zealand within the Wellington Yachting District.
- 2.2 Measurement is not required but each boat is expected to meet all class regulations.
- 2.3 Entry forms and registration will be accepted from 8.30am on the day of the regatta

#### **3.0 Fees**

- 3.1 The regatta entry fee is \$10.

#### **4.0 Schedule – Saturday 2nd November 2019**

- 4.1 Registration from 08:30 hours at Worser Bay Boating Club clubrooms.
- 4.2 Briefing at 09:15 hours in clubrooms.
- 4.3 Racing, 4 races are scheduled.
- 4.4 The target time for each race is 35 minutes.
- 4.5 The scheduled time for the warning signal for the first race is 1000 hours.
- 4.6 No warning signal will be made after 1630 hours,

#### **5.0 Completion of Series – Wellington District Tanner Cup Trials**

- 5.1 If less than 4 races are completed then the remaining required races will be completed on the next scheduled WBBC club race day, or at a date agreed between the Race Committee and competitors.

#### **6.0 Sailing Instructions**

- 6.1 The Sailing Instructions will be available at registration on the day and at [www.wbbc.org.nz](http://www.wbbc.org.nz) after 27<sup>th</sup> October 2019.

#### **7.0 Racing Area**

- 7.1 The races will be held in the vicinity of Worser Bay.

## **8.0 Courses to be Sailed**

8.1 The courses will be triangular, windward/leeward.

## **9.0 Scoring**

9.1 Four races are required to constitute a series.

9.2 No race score will be excluded..

## **10.0 Prizes**

10.1 Prizes will be given as follows:

Tanner Cup Trials: Sam Nixon Memorial Trophy.

10.2 The winner of the P Class Trials will eligible to be selected as the Wellington Yachting Association Representative for the 2020 Tanner Cup contest.

10.3 Other prizes may be awarded.
