AWARDS: Best of show - \$500 or a prize provided by the sponsor of equal or greater value

1st - \$300 or a prize provided by the sponsor of equal or greater value.

2nd - \$200 or a prize provided by the sponsor of equal or greater value.

3rd - \$100 or a prize provided by the sponsor of equal or greater value.

Honorable Mentions Cash or Merchandize to be awarded.

ELIGIBILITY: Open to artists of all levels. Artists must have an active membership with the Red Rock Pastel Society of Nevada to be eligible to enter the show. Upon acceptance every artist will be required to show the proof of his or her membership (a membership card, a cancelled check or an email from the society president, a PayPal confirmed donation). You may join at www.redrockpsnv.org/member

ENTRY DEADLINE: The entry form and the digital image of your work to be submitted as well as the payment of the entry fee to be validated on ShowSubmit.com before March 15th, 2019.

ELIGIBLE WORK: Please read carefully to make sure that your work meets the following entry requirements:

- Your works must be done with dry pastel; the final surface must consist of at least 80% dry pastel. No Oil Pastels can be used. In case you use a mixed media, the drawing must consist of mostly (80%) dry pastel.
- The work must be original, not copied from other artists or from any other published material.
- All artwork must be originally drawn and not created on top of a photo or a print.
- All works must have been created within the last two years.
- Paintings of nudes will be considered for acceptance.
- Works done under supervision (such as in a workshop or class) are not eligible.

Failure to meet any of the requirements may result in your work not being juried. No substitutions allowed.

March 15, 2019 – Entry Deadline

April 1, 2019 – Show Posted Online and Awards Announced

ENTRY FEE: The entry fee is \$25.00 for the first image and \$10.00 for each additional image. Up to 5 images may be submitted by an individual artist. Entry fees are not refundable and must be paid by the entry deadline.

ONLINE ENTRY: Entry is online only. Go to www.ShowSubmit.com and scroll down to the 1st Red Rock Pastel Society of Nevada Member Juried Webshow.

Please be sure you are entering the correct show. Follow the directions for entry. You do not need to have a PayPal account to pay the entry fee online, just a valid credit card.

Please follow these instructions carefully regarding the preparation of your images:

Only jpeg (or jpg) image files will be accepted.

Required image size is 900 pixels on the longest side.

Save your files with a resolution of 300 dpi.

NOTIFICATION: Up to 5 entries may be submitted from an individual artist. Please add office@showsubmit.com to your safe senders list to ensure email delivery. **All accepted works will be displayed on the Red Rock Pastel of Nevada website.**

ENTRY PROCEDURES FOR ARTISTS OUTSIDE THE UNITED STATES:

Use the same entry procedures as listed above.

FRAMING OF ARTWORK: If an artwork is for Sale framing details need to be specified.

SALES: Not for Sale works (NFS) will be accepted. No commissions will be charged. All buyers will be directed to the Artist's website (email), please make sure you have the correct information regarding the submission of your work. The Artist is responsible for the shipping of the sold work.

JUROR AND JUDGE: We will have **Marsha Hamby Savage** as our juror and awards Judge. Awards will be presented on April 1st Online. The link to live translation will be posted.

MEET THE JUDGE: Marsha Hamby Savage

Marsha has been painting for over 45 years and has taken classes and workshops from some great instructors during her journey of being an artist. There was no art school, just much study and learning from an extensive collection of art books, and miles of practice and observation. She is a Master Circle Member of the International Assoc. of Pastel Societies, a Signature Member of the Southeastern Pastel Society and the Southern Appalachian Artist Guild, an Associate member of the Oil Painters of America and American Impressionist Society. Marsha is also a founding member of the Eastern League of Professional Artists.

She has been accepted into and won numerous awards at many Regional, National and International Juried Exhibitions including several Best of Show Awards. Marsha's paintings can be found in the offices of the Speaker of the House - Georgia State Capitol, along with commissions for hospitals and restaurants, and in many personal art collections and a museum. She has been featured in American Art Collector, Pastel Journal, Southwest Art, and Plein Air Magazine. The Marsha Savage Southeast Landscape Set produced by Terry Ludwig Pastels is marketed all over the world. She is often asked by art organizations to demonstrate techniques and speak about marketing for the artist. Marsha teaches private lessons locally and workshops around the Country and overseas.
