Creating Complex Documents for Business Transactions

Challenges of Complex Documents

Large organizations generate significant volumes of business transactions. As customer requirements and government regulations escalate, these transactions have become ever more complex. The process of initiating them, capturing the business data to record them, and memorializing them in required contracts and documentation has become a critical challenge.

Organizations often struggle to initiate complex transactions in an organized, collaborative way, so that the business data collected in the process is reliable and the intent of their business transactions is accurately reflected in the required documents.

A Flawed Process

Organizations are most challenged when the transactions themselves or the required documentation is lengthy, logically complex, customized, highly regulated, and continuously evolving.

The processes used by most organizations to initiate and memorialize complex transactions are fundamentally flawed. Complex transactions require flexible, collaborative processes to capture them, however most processes are unorganized and only loosely connected to other business systems. They are often initiated using manual checklists, spreadsheets or other methods, and may even begin with legal experts manually word processing required documentation first in

order to capture business data. Even when more automated methods are used, they are generally not flexible enough handle the complex logic and team collaboration inherent in most complex transactions.

The Right Tools

Document Agility's rules-based approach to initiating and memorializing transactions provides organizations a set of tools that is flexible and powerful enough to initiate and memorialize complex situations.

Document Agility first converts an organization's storehouse document templates, clauses and other knowledge into automated rules templates and interviews. How it Works

The transaction data captured during the initiating process can be used in a variety of ways within your organization.
