# Safeguarding Update August 2019

## **Designated Safeguarding Officer**

It's recommended at least one person in your organisation is a 'designated safeguarding officer' (DSO). Section 11 of the Children Act 2004 places duties on a range of organisations and individuals to ensure their functions are discharged having regard to safeguard and promote the welfare of children. It's also recommended a deputy is appointed to cover sickness or leave. Here are details of our next DSO course coming up on Thursday, 19<sup>th</sup> September. Book a place. Just 3 places left!

# Domestic Abuse training (Free) (Recognising & Responding) Course

### Clare's Law Campaign

West Yorkshire Police are encouraging anyone with concerns about their current or expartner to use their 'right to ask' to check whether they have a history of domestic abuse. Applications can be made by males or females over the age of 16-years-old in heterosexual or same-sex relationships. <u>More information</u>.

#### Silent help

If you are in a situation where you cant' speak (choking, heart attack, intruder, domestic violence etc) you can call 999 and when they answer, press 55 and this tells them you need help, but can't speak and they will dispatch policy to you. <u>More information.</u>

# What to Do if you have Concerns a Child is at Risk of Harm New guidance from Bradford Safeguarding Children Board

This is just to remind professionals working with children and young people across Bradford & District that there have been some important changes as to how agencies should report their concerns about children and young people at risk of harm into Bradford Children's services. The new guidance aims to help agencies identify a child's level of need and to know how to respond appropriately, giving the right help at the right time. It is important that VCS organisations working with children and young people have an understanding of this new guidance. Here is a summary and all relevant documents can be found on the Bradford Safeguarding Children Board (BSCB) in the <u>'Documents and Resources' section</u>.

Please ensure all staff and volunteers in your organisation are made aware of this important new guidance and begin using it. You may find this <u>presentation</u> used at the launch event

helpful, as part of cascading this within your organisation. Here is a <u>summary</u> of the new guidance and resources.

And don't forget to take a look at their great range of free <u>BSCB e-learning resources</u> (topics include Basic Awareness of Child Abuse and Neglect; Domestic Violence, Early Child Development; Hidden Harm – the effects of parental problem substance use on children and more. Use these resources with volunteers and staff to run your own inhouse training. Participants will just need to get a log on by registering on a course and access to a computer to work through the training together, stopping for breaks for discussion.
