

**#DOGOOD & #GIVEBACK Positive Legacy &
Turkuaz Stuff a Bag Donation Contest

No purchase necessary to enter or win. All federal, state, local and municipal laws and regulations apply. Void where prohibited.

Positive Legacy & Turkuaz Stuff a Bag Donation Contest (the "Contest") begins on December 27th, 2019 at 7:00pm MST and ends on February 20, 2020 ("Contest Period"). This contest is in no way sponsored, endorsed or administered by, or associated with Instagram.

1. Agreement of Official Rules

Participation in Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the final decisions of Contest Hosts, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules, Instagram Rules and fulfilling all other requirements set forth herein.

2. To Enter

During the contest period, participants with an Instagram account, can post one video and a caption describing the activity in the video and how the activity supports the goal of doing good and giving back. The caption must include the Contest's dedicated hashtags of #dogood, #giveback & #leavealegacyontour, and the Contest hosts' @positive_legacy and @turkuazband must also be tagged. The Positive Legacy Bag stuffed with donations must be visible in the video. If participants do not have an Instagram account they can send their submission to info@positivelegacy.com . Hosts reserve the right to disqualify any entry that does not comply with the guidelines set forth in these Official Rules. Entries submitted without required hashtags and tags or without showing a stuffed donation bag will not be considered. Entries entered before or after the Contest Period will be disqualified. Limit one winning per person.

3. Winner Selection

All charities considered for selection must be registered 501(c)(3) nonprofit

organizations. After the Contest Period closes all valid entries, as vetted by Positive Legacy, will be submitted to the Turkuaz Panel of Judges to determine five finalists. The judges selection will be based equally on the following criteria: participant action demonstrates giving back and doing good in their community; creativity in video; caption is compelling and describes the action; and video quality. Decisions of the judges are final and binding.

4. Entry Restrictions

To be considered the entry must not contain, as determined by Hosts' sole discretion any content that:

- a. Is inappropriate, offensive, indecent, obscene, discriminatory, defamatory or endorses any form of hate or hate group;
- b. Contains copyrighted materials owned by others or images, names or information identifying others, without permission;
- c. Contains trademarks or logos owned by others without permission;
- d. Disparages hosts or any other person, organization, group or entity;
- e. Promotes activities that may appear unsafe or dangerous or violates any law.

5. Notification of Winner

Five (5) confirmed winners of the Contest will receive a one thousand dollar (\$1000) grant to the #dogood charity they donated their Stuff a Bag to. Positive Legacy reserves the right to approve all charities. Finalists will be notified on Instagram by Turkuaz, as well as by direct message and/or email.

6. General Conditions

- a. By participating in the Contest, each entrant: agrees to abide by Official Rules and the decisions of the Hosts; consents to Hosts' use of his, her, or their names(s), photographs, likeness, city, Instagram handle and statements for publicity purposes in all media without additional compensation; agrees to be contacted by Hosts by direct message on Instagram and/or email; releases hosts from all liability, loss or damage arising out of their participation in the Contest; and that no component of the entry infringes upon any other person's rights.
- b. Entrant understands that Entrant is providing information to hosts and not to Instagram.

7. Release and Limitations of Liability

By participating in the Contest, entrants agree to release and hold harmless Turkuaz, Leaving a Positive Legacy, Inc., and each of their respective partners, subsidiaries, affiliates, agencies and other companies associated and each of their officers, directors, employees, shareholders, and agents from and against any claim or cause of action arising out of participation in the Contest or the charity's receipt of the grant. Entrant waives the right to claim any damages whatsoever, including but not limited to, punitive, consequential, direct or indirect damages.

8. Hosts

The contest is hosted by Leaving a Positive Legacy, Inc. and Turkuaz.
