

# **Privacy Policy**

This document is to inform visitors and players regarding the policies of Skylab Entertainment ('Skylab') with regards to the collection, use, and disclosure of Personal Information.

If you choose to use any of Skylab's Services, you agree to the collection and use of information in relation to this policy. #### **Information Collection and Use**

To improve Skylab's Service, we may require you to provide us with certain personally identifiable information. The information that we request is retained on your device and is not collected by Skylab in any way.

# Google Play Services Log Data

We want to inform you that, whenever you use Skylab's Service, in a case of a crash or error in the app, we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing Skylab's Service, the time and date of your use of the Service, and other statistics. Again, we DO NOT use or share this information with anyone except as described in this Privacy Policy or for commercial use.

#### Cookies

Cookies are files with small amounts of data that is commonly used in a form of anonymous unique identifiers. These are sent to your browser from the website that you visit and are stored on your device's internal memory.

Skylab's Service does not use these "cookies" explicitly. However, it may use third party code and libraries that use "cookies" to collect information and to improve their services.
