# **Position Description**

### West Coast Warriors Netball Club Committee

#### President

The President shall preside at meetings of the West Coast Warriors Netball Club Committee. They shall represent the West Coast Warriors Netball Club whenever possible or delegate such duties to other members of the Committee. They shall liaise Netball WA. and outside relevant parties.

#### Vice President

The Vice President shall, in the absence of the President, preside at meetings of the West Coast Warriors Netball Club Committee. They may act as liaison between the West Coast Warriors Netball Club and Netball WA as and when required. The Vice President is required to attend monthly committee meetings.

#### Treasurer

The Treasurer will be responsible for managing the finances of the West Coast Warriors Netball Club in conjunction with the West Coast Warriors Netball Club President. They will attend monthly West Coast Warriors Netball Club Committee Meetings.

#### **Warriors Coordinator**

#### Secretary
