

PUR2o is a local New Jersey based company in the business of clean, safe and healthy water. Of course, PUR2o is a for-profit business, but it is not just a regular business, it is owned by two compassionate human beings, who are just like those struggling with the water crisis.

WE JUST WANT TO HELP, We are not in a position to offer 15,000 water systems for free to all the homes in the at risk area, but we will do our best as a company to stand by our community and help those who we can, so that at least some of our children, our pregnant women, our elderly, and everyone else can get through this with minimal health concerns and be able to sleep at night and know their family is safe.

We are asking our PUR2o community of clients and partners to help by contributing to an "adopt-a-family" program, to collect funds to be able to install a basic RO water system to a Newark family, and get clean water to them as soon as we can. We are doing our best to raise awareness for our program, and every time we receive any funds from our community we will use it to install another system for another family, for as many as we can. Even if we are able to install only one system, at least we know we have made even the smallest difference.

The information you provided on this form will be held in strict confidence. We are collecting your information to determine your eligibility for our adopt-a-family program. We may keep your information on file until the water crisis is completed or until you no longer have a PUR20 water system installed in your residence, which ever is longer. We are using the information solely for the purpose of selecting qualifying participants and choosing those most at need. During the selection process PUR20 shall not discriminate against families or individuals on the basis of race, religion, national origin, color or gender. Our qualifying factors are based on the household size, whether the household is deemed high-risk (including children, pregnant women, disabled and/or elderly), accessibility to clean water, and proximity to the Newark Water Crisis. Participants cannot be PUR20 employees or related to employees of PUR20. PUR20 makes no guarantees or representations of the number of systems that they will install, if any.

If selected for the program for a water filtration system, the participant understands that their household will receive one reverse osmosis water filtration system to be installed under the sink in the kitchen of the eligible residence. The system will be no cost to the participant. This system requires an annual maintenance and filter change that PUR2o can assist with. Before and after the installation of the system a water quality expert will conduct a water test to confirm the system is working properly. The system is appropriately NSF certified to filter up to 99.9% of contaminants, including Lead 93-98%. The system includes a 1 year limited warranty that covers installation and parts.

The participant releases PUR2o from all liability relating to injuries that may occur based on the contaminants in the tap water supply being provided to the home. By signing this agreement, I agree to hold PUR2o entirely free from any liability, including financial responsibility for injuries or health problems incurred, regardless of whether injuries are caused by negligence.

Indemnity Clause. I agree to Indemnify and hold harmless PUR2o and its subsidiaries, officers, directors, agents, employees, clients, volunteers and representatives for any and all claims arising out of or resulting from, or alleged to have arisen out of or resulted from, my engaging in or participating in the adopt a family water filtration program.

Release And Waiver. I waive and release any and all claims that I may have in the future against PUR20 and its officers, directors, agents, employees, clients, volunteers and representatives which are in any way associated with the adopt a family water filtration program.

I agree to grant to PUR2o and its authorized representatives permission to record on photography film and/or video, pictures or any interview content of my participation. I further agree that any or all of the material may be used, in any form, as part of any future publications, brochure, or other printed materials used to promote the Newark water Crisis Adopt a family campaign, and further that such use shall be without payment of fees, royalties, special credit or other compensation.
